# MESSAGE FROM CATYC PAST PRESIDENT

Hello CATYC,

We all share the same desire to amplify success for our commuter and online student populations who are hardest to reach with traditional support approaches.

At VU specifically, we partnered with CircleIn after reviewing the plan of empowering our entire student body to unite as one powerful digital community and unlocking the students to help each other succeed academically. We have almost 1 in 2 students who have adopted CircleIn, and for our student demographics, we all know there are very few services 1 in 2 students use. At similar commuter schools they've demonstrated 8% improvement in retention rates, and as high as 33% improvement in pass rates in high failure rate courses. We look forward to jointly evaluating the impact with CircleIn as our adoption continues to rise.

"Shifting Gears In Higher Education," September 25-27, 2022, Indianapolis, IN

INDIANAPOLIS - The landscape of higher education is changing, and institutions are shifting gears. The Council on Accreditation for Two-Year Colleges held a three-day event titled "Shifting Gears in Higher Education" from September 25-27 in Indianapolis, the racing capital of the world.

Vincennes University President and outgoing CATYC President Dr. Chuck Johnson hosted the conference. According to Johnson, "We were pleased the CATYC held its annual fall conference in our state's capital, offering attendees the opportunity to experience Hoosier hospitality. The CATYC Conference brought together dedicated college leaders, faculty, and staff from throughout the nation who engaged in the impactful sharing of knowledge that could make their institutions better and spur new goals."

Fifty-five participants from 14 of the 19-state region attended interactive sessions focused on various challenges and issues facing colleges in fulfilling their missions and meeting accreditation

standards, including assessment of learning, student engagement and success, aligning K-12 and higher education, developing leadership teams, and workforce development. In addition to the numerous informational presentations,





Vincennes University hosted the conference attendees at their Indianapolis Aviation Technology Center. The university hosted a reception and tour of their facility filled with airplanes, motors, and simulators. It was a great evening to learn and network.

Indiana Commissioner for Higher Education Chris Lowery was the conference's keynote speaker. "The State of Indiana is honored to have served as the site of the Council on Accreditation for Two-Year Colleges Fall



Conference," Lowery said. "This event is an important annual conference of college and university administrators, faculty, and staff who are passionate about helping all learners realize their dreams through higher education. Community and junior colleges continue to serve a critical role in our communities by providing pathways to accessible and affordable education for all, upward mobility, and offering great value to learners striving to achieve a postsecondary credential." Lowery discussed the dramatic decline of the college-going rate in Indiana and efforts to reverse the trend. His speech was very much in alignment with the theme of the CATYC Conference.



Dr. Brian Inbody, President of Neosho Community College in Kansas, received special recognition for his commitment to the CATYC and higher education. Inbody was presented the Legacy Award by Johnson. The 2022 Fall Conference

concluded with Dr. Bruce Moses, President of Allen County Community College in Kansas, taking over as CATYC

#### GEORGE KNOX RESEARCH GRANT RECIPIENT

Lake Area Technical College (LATC) in Watertown, South Dakota was chosen by the Executive Committee of the Council on Accreditation for Two-Year Colleges (CATYC) to receive the CATYC George Knox Research Grant for 2022. Gina Grant, HLC Liaison Officer/Assessment Coordinator, submitted the proposal. The research grant was established to benefit the institution, recipient, the organization, and higher education by supporting institutional improvements and best practices related to accreditation.

The grant funds (\$1500) will assist LATC to define and develop a co-curricular program and framework of learning outcomes. This will be accomplished by establishing a multi-discipline student focus group of 25 students to assist a task force to develop co-curricular learning outcomes and testing standard processes. Ms. Grant will present the project findings at the CATYC Annual Conference in Phoenix/Tempe, AZ in October 2023.

Members interested in applying for the 2023 George Knox Research Grant are encouraged to apply - proposal deadline is January 15, 2023.

# LEGACY AWARD RECIPIENT, DR. BRIAN INBODY



Dr. Brian Inbody, President of Neosho County Community College (NCCC), was awarded the 2022 CATYC Legacy Award. The Legacy Award recognizes and acknowledges the long-term, positive, and significant impact of an individual or group who have contributed to the

CATYC organization. Dr. Brian Inbody has demonstrated his commitment to CATYC and higher education for many years. He has been a member of CATYC for 16 years, serving on the Executive Committee, and as Vice-President, President-Elect, President, and Past-President of the organization.

Dr. Inbody has had a full and active career in higher education for over 30 years. He has served as the President of NCCC for 12 years, serving seven years as the Vice President for Student Learning, prior to his presidency. He has also served as faculty and administrator at colleges in Oklahoma and Michigan. # **Higher Learning Commission Updates**

The 2023 HLC Annual Conference is March 25-28, 2023.



Information from CATYC Conference presentation of Dr. Karen J. Solomon, Ed.D., HLC Vice President and Chief Transformation Officer:

# Substantive Change

- Revised application forms posted Sept 2022
  - Eliminate old forms or weblinks
- Significant changes to the New Program application coming Fall 2023
- Increased emphasis on anticipated student outcomes, evidence of market demand, etc.

# Changes in Program Content

- 25% threshold for programs
- 50% threshold for certificates
- NOTE: The same screening form is used for both credentials

# Change of Modality

- Still awaiting clarification from USDE
- For institutions approved for "distance education courses and programs," should be able to submit a spreadsheet listing all the distance education programs
- Filing details will be posted in Leaflet once clarification received

#### Prison/Carceral Education

- Awaiting final rules from USDE and HLC procedures will likely need to change
- Anticipate increased scrutiny of facilities and curriculum
  - Potentially effective July 1, 2023
- 2nd Chance Pell experimental institutions will be operating under different regulations

# Federal Recognition

- Entering final phase of HLC's renewal process for federal recognition as an institutional accreditor
- HLC's NACIQI (National Advisory Committee on Institutional Quality and Integrity) hearing to be held in February 2023
- Recommendation is considered by a senior department official HLC Updates

# Revision of the Criteria for Accreditation

- Process beginning in-house Fall 2022
- Opportunities to attend listening sessions at the 2023 Annual Conference
- Anticipated to go into effect September 1, 2025
- Presently working on proposed language regarding dual credit

# **Differential Accreditation**

- Differential Accreditation Advisory Committee (DAAC) met four times in 2021-2022
- Recommendations to be considered at the HLC Board of Trustees Fall 2022 meeting
- Timeline under development for launch of pilot

New Student Guide launched in October, 2022.
